Subject: Staff update on COVID-19 communication to students and training opportunities

Dear all Med School Staff,

Again, just to keep you all updated on communication sent to students, decisions made on current teaching and on some training resources available online and in person next week:

Below the line is the email sent to Year 1 and 2 ScotGEM students today regarding their teaching. We will be communicating plans to all students (including the BSc Hons and MSc Health Psychology students) during Spring Break, but as ScotGEM continues over the two weeks of spring break we needed to release this information to them in a timely way. It's in line with our approach on the BSc re: placements.

In additional, we have suspended MSc Health Psychology secondary care placements during Spring Break too, and we have also suspended the use of simulated and volunteer patients at present and will review this in two weeks' time.

ScotGEM has specific plans to preserve teaching and assessments as far as circumstances allow with an increasing shift towards virtual delivery, withdrawal from clinical environments and potentially university closure. This is different from the BSc students as your GCM based teaching is a core component of the course structure. To optimise your chances of completing coursework and assessments please take all precautions to avoid risk of illness or need for self-isolation, including travel, given the potential impact of this on your studies. Until further notice please note the following guidance:

Specifically

Re Year 1

- GCM teaching is scheduled to continue till w/c 3rd June.
- We are planning to continue CBL within the medical school or virtually if required. Do not attend your GCM practice until further notice.
- CLIC sessions will continue as planned, however without simulated patients (we will use scripts as case-based discussion instead).

Re Year 2

- The Agents of Change block should not involve clinical patient contact but individual projects will be reviewed as required. Discuss with your GCM.
- PJ/EC Clinical and Pre-hospital placements within this block may need to be cancelled but will await developments before making this decision.
- It is currently expected that you will be able complete the block after the holidays using simulation in local simulation facilities in region.

Re Assessment

- Many options are being worked up that should allow you to complete your assessments largely as planned but of course events may overtake us.
- Arrangements are being sought that, if necessary, could allow you to provisionally progress into the following year pending deferred assessment at a suitable time.

These are challenging times and I trust this will reassures you that the School and University, have detailed contingency plans and that all reasonable steps are being taken to minimise disruption to your studies. The number of cases in Scotland is currently small but please look after yourselves and do what you can to continue your studies safely.

This is a changing situation and it is particularly important that you check your emails regularly for any announcements.
